Demand rise in Europe maintained through the summer

European new registrations of all categories of commercial vehicles remained on an upward trend in July and August. July result was positively influenced by one extra working day in the whole region (two in Belgium and France). The demand for new vans went up by 15.6% in July and by 11.9% in August, and over eight months it was 7.7% higher than last year. The truck market (above 3.5 tonnes) has been surging since May this year, thanks to the general economic upturn and an increase in orders because of last year's distinct fall in purchases following the introduction of the digital tachograph in May 2006. The registrations of new trucks rose by 27.5% in July and 20.8% in August, reaching a cumulative increase of 5.3% by the end of the period. Bus and coach registrations declined between January and August by 4.9% despite good results in July (+12.9%) and August (+3%).

JULY

New Light Commercial Vehicles up to 3.5t (vans)

With 181,305 new vans registered in Europe (EU23+EFTA) in July, the market went up by 15.6%. This result was positively influenced by one extra working day in the whole region (two in Belgium and France). Western Europe reported a 14.2% rise and registrations in the new EU member states surged by 34.2%.

Almost all the EU countries posted two-digit growths in July. France was the most dynamic among the main markets (+24.8%), followed by Germany (19.1%), the UK (14.1%), Italy (12.1%) and Spain (3.2%). Only Denmark and Portugal saw their registrations drop (-20.3% and -19.5%, respectively). All the new member states performed better than July last year, with Slovakia (+55.6%) and Slovenia (+52.7%) leading the way.

New Heavy Commercial Vehicles over 16t (excluding Buses & Coaches)

New heavy truck registrations in Europe rose by 31.6% in July, with the new member states soaring by 79.6% and Western Europe by 26.4%. The truck market has been booming since May 2007, thanks to the general economic upturn and an increase in orders because of last year's distinct fall in purchases following the introduction of the digital tachograph.

All EU markets experienced a strong upturn in their heavy truck registrations. Demand in Germany reached record level (5,117 trucks, +52.2%) and the remaining large markets posted solid growths: UK +26%, Spain +17.2%, Italy +6.4% and France +6.2%.

New Commercial Vehicles over 3.5t (excluding Buses & Coaches)

The market developments in the heavy truck sector were mirrored by the registrations of new commercial vehicles above 3.5 tonnes. Europe's registrations went up by 27.5% in July, reaching a total of 35,622 new trucks.

Western Europe saw registrations increase by 23.3% thanks to a solid growth in most of the EU15 countries. The results in the main markets ranged between +0.9% in Italy to +36.9% in Germany. Many of the new EU members almost doubled their last year's result and reached an overall gain of +67.3%.

New Buses & Coaches over 3.5t

New bus and coach registrations in Europe (EU21+EFTA) increased in July by +12.9%. All the EU15 countries positively contributed to this result (+18.9%) while the new member states saw their registrations decline (-43.1%).

AUGUST & cumulative (January to August)

New Light Commercial Vehicles up to 3.5t (vans)

In August, 141,033 new vans were registered in Europe (EU23+EFTA), a yearly increase of 11.9%. With the number of working days unchanged from the previous year, Western Europe and the new member states saw their registrations pick up by 10.7% and 24.4%, respectively.

The situation on the main markets was mixed. Registrations in Germany (+44%), in France (+17.1%) and in Italy (+16.4%) kept on increasing but in Spain and the UK the figures dropped (-4.8% and -3.7%, respectively). Apart from Denmark (-29%), Portugal (-18.1%) and Lithuania (-33.7%), all the remaining EU countries posted growths.

The **cumulative figures** (January to August) showed a 7.7% improvement compared to the first eight months of last year. Western Europe's registrations (+6.5%) were boosted by the gains on the main markets ranging from +0.8% in Spain to +12.6% in Germany. Within the EU15 only Denmark (-0.5%) and Greece (-2.2%) saw their markets slightly downsize. All the new member states positively contributed to their overall result (24.5%).

New Heavy Commercial Vehicles over 16t (excluding Buses & Coaches)

With 22,874 new heavy trucks registered in August, European markets went up by +22.3%. The growth was very dynamic in Western Europe (+19.1%) and even more in the new EU member states (+49.4%).

Registrations picked up again in Germany (+41.5%), Italy (+26.5%) and Spain (+11%) and shrunk in France (-1%) and in the UK (-9.2%). All the remaining countries, apart from Belgium (+7.4%) and Estonia (+9.1%) posted two-digit growths and more.

An upswing on the truck market resulted in a **cumulative** eight-month 7.6% increase in registrations compared to the same period last year. Despite a drop on the UK market (-25.1%) and almost unchanged French (-0.3%) and Italian (-0.4%) registrations, Western Europe remained on an upward trend (+2.6%). Spain (+15.9%), Germany (+6.1%) and the majority of other countries posted increases. New member states strongly improved their result (+56.9%).

New Commercial Vehicles over 3.5t (excluding Buses & Coaches)

New commercial vehicle market in Europe expanded by 20.8% in August 2007, accounting for 32,474 trucks registered. The new EU member states' registrations climbed by 46.7%.

Apart from France (-3.3%), all other countries posted growths. Among the main markets, increases ranged from 9.7% in the UK to 27.2% in Germany.

According to January – August **cumulative figures**, Western Europe (+1.2%) managed to reverse the first half-year slowdown (-4%). A solid 47.2% increase in the new member states' registrations strengthened the overall European result (+5.3%).

New Buses & Coaches over 3.5t

The market for new buses and coaches in Europe (EU21+EFTA) improved in August by +3%. Registrations increased on all the largest markets, apart from Spain (-34.5%). The new member states saw their bus & coach market downsize (-19.3%).

The eight-month **cumulative** loss was reduced (-4.9%) as a result of an upturn in the new member states (+3.4%) accompanied by a slowdown in Western Europe (-5.6%).
